# **CALL TO ORDER:**

Kevin Johnson said Nate with Landmark has given us a proposal to treat lawns front and back (seven applications per year, same as LawnAmerica) for \$100.00/residence for a total of \$3500.00 per year. Kevin Johnson will ask Landmark to commit to \$100/residence, for a two year period.

#### Streets:

Brashears Powder Coatings gave Kevin an estimate that was too expensive and he will look for another street repair person.

### Curbs

Repairs to curbs where identified have been completed.

#### Fences:

Repairs to exterior HOA fencing have been completed.

# **NEW BUSINESS:**
